Purpose of the data processing

Your data will be processed for the purpose of organising and running the event 'PATHS2INCLUDE Consortium Meeting, Policy Forum & Review Meeting 2024'.

Legal basis of the data processing

The legal basis for the data processing of the mandatory information in the registration form is Art. 6 (1) b) DSGVO. In addition, further optional information can be provided voluntarily in the registration mask. The legal basis for the data processing of the optional information is consent in accordance with Art. 6 (1) a) DSGVO. Your consent in accordance with Art. 6 Para. 1 lit. a) DSGVO is the legal basis for the inclusion of your first and last name as well as your institution in the list of participants.

Obligation to provide

You are not obliged to provide this information, however, participation in the event is only possible if you provide us with the required and mandatory data. The communication of the other, optional data is not required and is on a voluntary basis.

Revocability of consent

You can revoke your consent to the processing of the optional information and the inclusion of your data in the list of participants in accordance with Art. 6 para. 1 lit. a) DSGVO at any time with effect for the future. In this case, we will no longer process this data and delete this data. The legality of the data processing until the revocation is not affected by this. The revocation is possible informally via the above contact details of the responsible person.

Storage period

We will process your data for as long as is necessary for the planning and final implementation of the event or on the basis of applicable legal provisions, such as the obligation to retain invoice documents. If you wish your data to be deleted, we will delete your data without delay, unless legal retention obligations apply.

Categories of personal data processed

- Name
- Institutional affiliation and place
- Email address
- Dates of event attendance
- Participation at meals
- Consent questions

Recipients of the personal data

- Staff members entrusted with the implementation of the event at the LUH Institute of Sociology.
- If you consent, your surname, first name and institution will be included on the list of participants, which will also be used to print name badges.

Your rights

You have the following rights regarding your personal data (according to Art. 15 to 21 DSGVO):

- Right to information
- Right to rectification and completion
- Right to erasure
- Right to restrict processing
- Right to data portability / right to receive a copy

Right to object

You also have the right to object to data processing at any time. We will then no longer process your data, unless there are compelling reasons for the processing worthy of protection or the processing serves the assertion, exercise or defence of legal claims.



Right of appeal

In addition, you have a right to lodge a complaint with the supervisory authority if you believe that the processing of personal data concerning you is in breach of the law.
